



STANDARD REPRESENTATION CONTRACT

BETWEEN

PLAYERS' AGENT AND PLAYER

1. The parties

.....
Name and address of licensed players' agent

Player's name, address and date of birth

have agreed to conclude the below contract on the basis of the following:

Before this contract was signed, the player was informed in writing that he or she should seek legal advice regarding the content of the contract. In Annex 1 to this contract, the player has stated whether he or she obtained legal advice before signing the contract or decided not to obtain such advice.

2. Duration

This contract shall enter into force on20... and expiry automatically on20... (duration cannot exceed two (2) years). The contractual relationship may be renewed during the term of the contract by entering into a new representation contract (see Article 10-4).

3. Exclusivity

The parties must select alternative a) or b).

a) The parties agree that this contract grants the players' agent a general exclusive right to represent the player during the period covered by the contract.

b) The parties agree that this contract grants the players' agent an exclusive right to act on behalf of the player in the following countries or vis-à-vis the following clubs during the contract period:

If alternative b) is selected, the player may enter into agreements with other licensed agents for other countries/clubs.

Regardless of whether alternative a) or b) is selected, the player may handle negotiations regarding transfers, loans or personal contracts on his or her own (see Article 2-6 last subsection).

4. Remuneration/fee

The parties agree that the player shall pay the following fee on the basis of an invoice from the agent for work the agent has performed under this contract:

NOK as a lump sum when the player contract enters into

NOK allocated over the contract period with equal
instalments at the end of each year.

These amounts are exclusive VAT.

The agent shall cover all costs associated with the performance of work defined in this contract and annexes thereto (see Articles 12-1 to 12-4).

After the negotiations regarding a transfer or the player's personal contract have been finalised, the player may issue a written authorisation stating that the club pay the player's agent. The authorisation must state what is agreed between the player and agent in the representation contract (see Article 12-6). The club must handle such payments in accordance with the national tax regime.

5. The agent's obligations

During the contract period the agent is obliged to

- safeguard the interests of the player in a professional and conscientious manner,
- keep the player informed about all issues of significance for him or her,
- not bind the player economically or in some other manner without his or her permission,
- ensure that he or she and his or her employees act in accordance with applicable requirements stipulated by the national association and FIFA,
- maintain the licence and insurance according to the Players' Agents Regulations, and
- neither directly nor indirectly pay or receive any type of benefit to/from clubs or others that violate the Players' Agents Regulations.

6. The player's obligations

By signing this contract the player confirms that he or she is not bound by any other corresponding agreement.

During the contract period the player is obliged to

- not enter into contracts that may come into conflict with this contract,
- inform the agent of negotiations with clubs outside the scope defined in subsection 3 b,
- inform the agent of all inquiries and offers from other agents, clubs and others that directly or indirectly act on behalf of a club,
- act in accordance with applicable requirements stipulated by the national association or FIFA, and
- give the agent the information necessary to allow him or her to safeguard the player's interests in a professional and conscientious manner.

7. Supplementary agreements

The parties may enter into supplementary agreements to this contract on the condition that these agreements are directly associated with the agent's activities as a players' agent. Such agreements shall be in writing and in compliance with applicable regulations in the countries and football associations where the agent, player or club are domiciled. Any supplementary agreements directly linked to agent activities under the NFF Players' Agents Regulations, shall be dated, signed and submitted together with this contract (see Articles 10-1 and 10-8).

8. Termination of representation contract

- a) The parties can agree to terminate the representation contract at any time during the contract period. Relevant national associations shall be informed in writing immediately.
- b) If the agent goes into compulsory liquidation, has returned the licence or the licence is withdrawn permanently, all representation contracts shall expire as of the date of the final decision.
- c) The player may terminate this representation contract unilaterally if
 - the agent defaults on his or her obligations under this contract or supplementary agreements (see Section 7), and the default is not remedied within 30 days after the player has pointed out the default in writing,
 - it can be demonstrated that the agent, his or her employees or others that represent him or her during negotiations regarding the player's transfers/loans or personal contracts have violated applicable regulations stipulated by the national association or FIFA, or
 - the agent's licence is suspended temporarily.

If the contractual relationship is terminated in pursuance of literae a), b) or c), the parties' rights and duties under this contract shall be terminated as of the same date. The player may claim damages from the agent if termination in pursuance of litera c) has resulted in significant losses or nuisance.

- d) The agent may terminate this representation contract unilaterally if
- the player defaults on his or her obligations under this contract or supplementary agreements (see Section 7), and the default is not remedied within 30 days after the agent has pointed out the default in writing, or
 - the player has withheld information that is material for allowing the agent to fulfil his or her obligations vis-à-vis the player.

If the contractual relationship is terminated in pursuance of litera d), the player is obliged to fulfil his or her obligations under Section 4 of this contract.

9. Third party rights

No parties other than the contractual parties can directly or indirectly influence the rights under this representation contract or the contract itself.

10. Disputes

By signing this contract the parties agree to submit all disputes regarding the validity or understanding of this contract to the NFF Arbitration Scheme. The same applies to other disputes between the contractual parties resulting from this contract or annexes thereto (see Chapter 24).

11. Final provisions

This contract and its supplementary agreements are issued in four (4) originals, each duly signed.

The players' agent is responsible for ensuring that the four signed originals with supplementary agreements are distributed with one each to the following

- The player that is a party hereto
- The player's football association
- The players' agent's football association
- The players' agent

The originals shall be distributed as quickly as possible and no later than five (5) days after the contract was signed.
